I. Describe as briefly as possible the circumstances of the offense[s]: DANIEL ORIN REED WAS ARRESTED FOR IMPERSONATING A POLICE OFFICER, HAVING A WEAPON IN HIS POSSESSION CAPABLE OF BEING CONCEALED. OTHER CHARGES STEMMING FROM THE ARREST INCLUDE A CHARGE OF INDECENT EXPOSURE SOLICITING FOR PROSTITUTION AND RECEIVING STOLEN PROPERTY. REED HAD BEEN IDENTIFYING HIMSELF AS A POLICE OFFICER WITH THE INTENTION OF GAINING SEXUAL FAVORS FROM PROSTITUTES ON ELCAJON BLVD. UNDER THREATS OF ARREST IF THEY DID NOT COMPLY. BOTH REEDS VICTIMS SAW A BADGE AND FELT A GUN AND PAIR OF HANDCUFFS UNDERNEATH THE SEAT OF REEDS VEHICLE. REED HAD AN OUT OF STATE LICENSE PLATE FROM NEW YORK ON HIS VEHICLE, GAVE A VISTA CALIFORNIA ADDRESS, HIS CHECKBOOK
